



### CONDITIONS OF REGISTRATION

- ❖ Attach a photocopy of the Identity Card / Passport and 4 photos.
- ❖ **Payments:** The transfer should be made payable to Centre d'Estudis Cinematogràfics de Catalunya, and specify the name of the student and the course. Please fax a copy of the receipt of transfer to number **93 456 88 50**. All bank charges incurred for the issuance and circulation of receipt will be supported by CECC, except the fees and charges that may accrue from repayment of unpaid bills and the rotation of a second bill being the minimum commission of 1.5% of the unpaid fee. CECC reserves the right to execute the decline of the student in case of default of two consecutive quotas, except those expressly authorized by the management of CECC.  
  
The student agrees to make the payment of the course according to the price sheet of the curriculum. Once you have completed the payment of the reservation and / or course fee in cash or the respective monthly payments by installment, CECC will not return this amount under any circumstances. The amount paid by the student is personal and not transferable. The fractionated payments will be made from 1 to 7 of each month.
- ❖ **Independent Courses:** Registration in one course is independently from the other courses, what doesn't mean that registration in a course entails the obligation to attend the full program.
- ❖ **Data Transfer:** In compliance with the provisions of L.O. 15/1999, 13th December, on the Protection of Personal Data, the data given will be incorporated to the personal files of whom CECC is responsible. The student is informed and gives its consent to the inclusion of their data to the computer files owned by CECC and the automated processing thereof. The student has the right to access to the information from your data, correct it if the details are incorrect and / or request cancellation of that file. - ❖ **Care and maintenance of equipment:** The material available to CECC student is of great cost, so that students will care and will use it as as possible. Otherwise, the student must respond to CECC.
